



Premium EverVolt Marine Warranty Policy

Standard 12 months free replacement period from the date of purchase.

CLUB ASSIST LIMITED WARRANTY FOR MARINE/RV BATTERIES PURCHASED ON AND AFTER JANUARY 1, 2023

Club Assist U.S. LLC (CA), an independent company from AAA, warrants to the AAA Member that this battery is free of defects in materials and workmanship, for the designated number of months outlined below. Should any battery fail to perform due to a defect in material or workmanship, and is not merely discharged, it should be returned to an authorized marine/RV Battery Service Provider or Distributor along with the original bill of sale. This warranty is applicable only to the AAA Member that purchased the AAA marine/RV battery.

Batteries will be warrantied as outlined below. No cash refunds.

Within twelve (12) months from the date of original purchase, all marine/RV Batteries sourced from AAA for marine/RV vessels found to be defective in materials or workmanship will be replaced free of charge. Warranty does not cover removal of old battery or installation costs for the new battery.

Within one (1) month from the date of original purchase, all batteries designated for commercial marine/RV vessels found to be defective in materials or workmanship will be replaced free of charge. Warranty does not cover removal of old battery or installation costs for the new battery.

WARRANTY EXCLUSIONS:

The Club Assist limited warranty provides for battery replacement resulting from manufacturer defects only; it does not cover premature failure due to the neglect, damage, or abuse of the battery.

Warranties do not apply in the following cases: a) the battery is merely discharged and still serviceable; b) the container, covers, or terminals are broken; c) the battery has been frozen or damaged due to neglect or abuse; d) the battery is damaged due to over or undercharging; e) the battery fails because of fire, collision, wreckage or explosion or because of a faulty electrical system; or, f) a battery is used in applications for which it was not designed, or is installed or charged in reverse polarity.

Any marine/RV Battery that is used in a non- marine or non-RV application will void the warranty as it is not recommended or built for those applications. This includes, but is not limited to the following: golf carts, electric wheel chairs, non- marine/RV power sports applications, and lawn mowers.

THE WARRANTIES PROVIDED HEREIN MAY NOT BE ASSIGNED OR TRANSFERRED BY THE ORIGINAL USER AND ARE THE EXCLUSIVE REMEDY FOR ALL CLAIMS, DAMAGES, OR LOSS ARISING OUT OF DEFECT OR FAILURE OF A BATTERY. CLUB ASSIST IS NOT LIABLE FOR CONSEQUENTIAL, INCIDENTAL, COMMERCIAL OR PROPERTY LOSS OR DAMAGE, WHETHER BASED UPON TORT OR CONTRACT OBLIGATION.
